Article IV Membership

As currently written in Constitution

The Friends of the James E. Brooks Library is a voluntary, non-profit organization working in cooperation with Central Washington University Foundation. Any person interested in the purpose of this organization and contributing finances, resources, and/or services to it shall be a member.

CHANGE last sentence to read: Any person interested in the purpose to this organization and contributing finances, resources, and/or services may apply to serve or the board.

Second change:

Article V Officers and Organization

As currently written in Constitution

The officers of this organization shall consist of:

Section 1 (1)

Between nine and fifteen members of a Board of Directors elected by a majority vote of these members present at the annual meeting of the members of the organization for terms of three years. Board members may serve two consecutive terms before leaving for at least one year.

CHANGE to read

The board shall consist of nine to fifteen members. New members will be voted on after a review of application and statement of interest letter. New members will be invited to apply during the summer months but may also apply anytime during the year if positions are open. The board president will send out the applicants information to board members and shall call for a vote in person, phone, or email. New members will be voted in by a majority vote of the board.

Board members may serve two consecutive terms before leaving for at least one year.

Third change:

Section 2

Add (6) Meetings shall be conducted by using Roberts Rules of Order.

Constitution Revision Vote (postponed until June, per existing bylaws)
